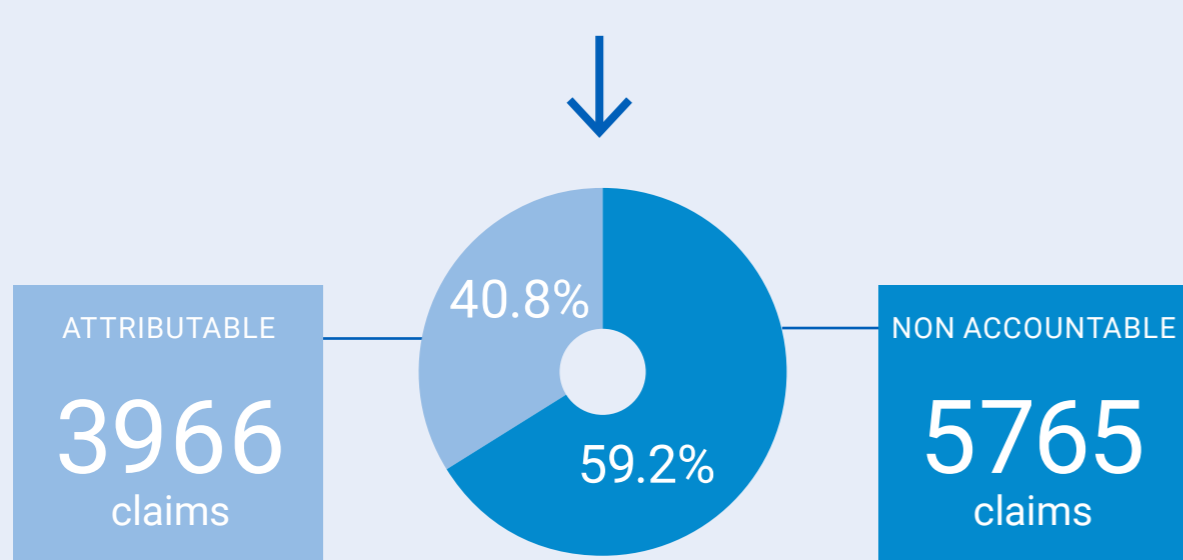

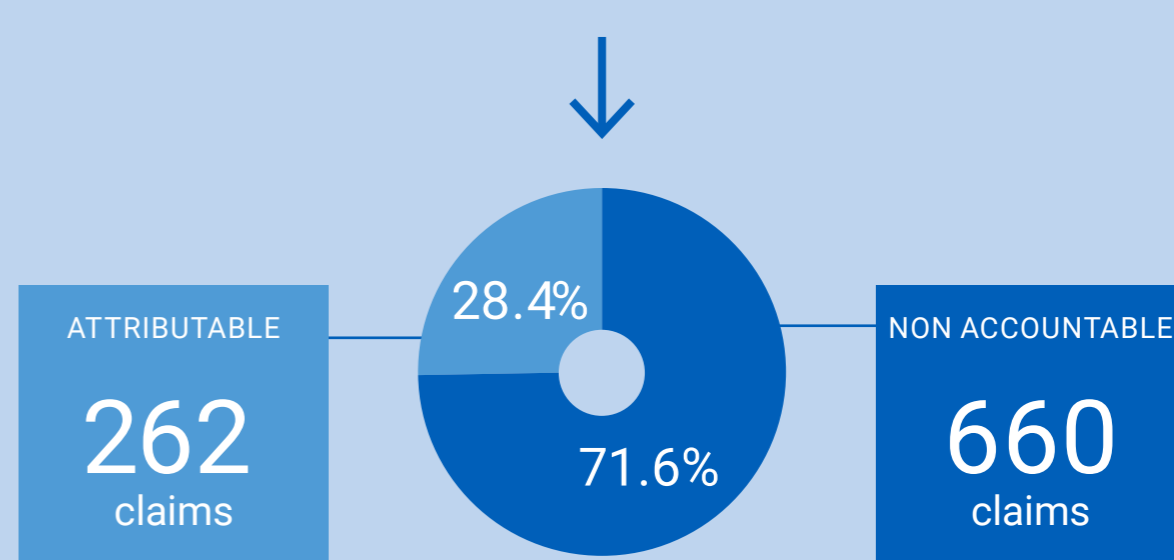

## STATUS OF PATIENT CLAIMS PROCESSED ACCORDING TO THE ONIAM PROCEDURE

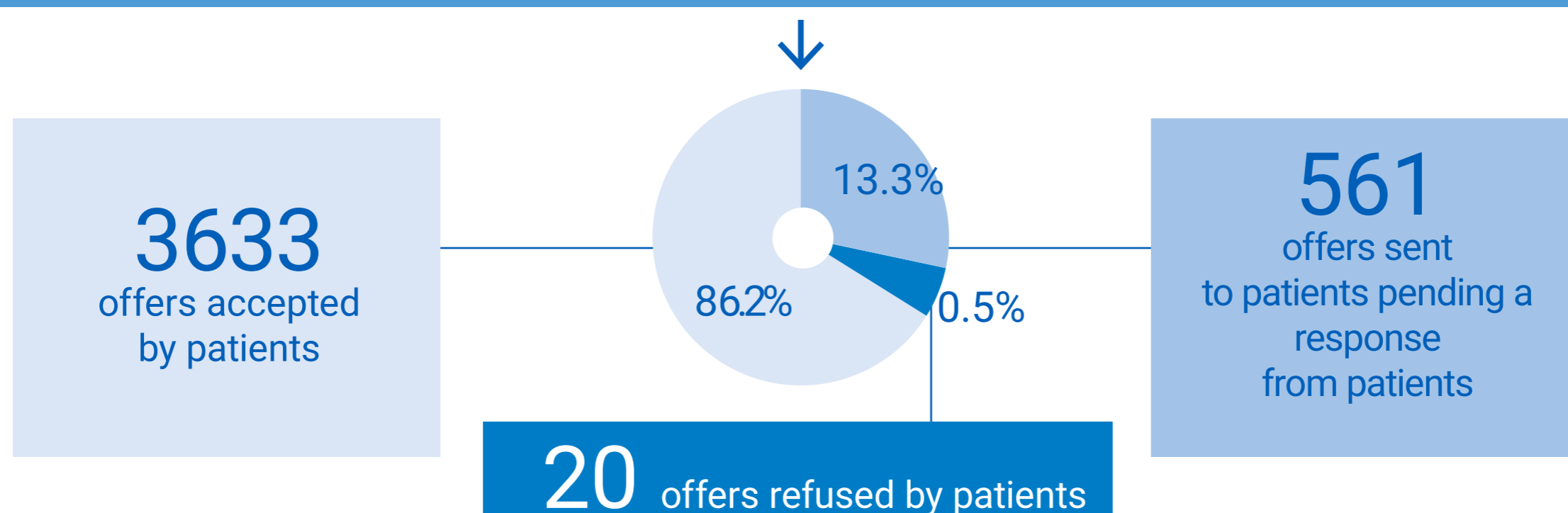
**3966** accountable files (for 9731 reviewed files)

## Status of patient claims processed by civil courts and concluded by a settlement agreement

On 31 December 2024, 4430 patients received offers of compensation for a total amount of 274.9 million Euros, 236.7 million of which have already been paid

(1) The above data concern claims initiated either by the ONIAM procedure or by those of the civil courts.

(2) The claims examined correspond to files that were the subject of an ONIAM report or opinion as well as the judicial files that were the subject of a judicial decision or an expert report allowing a decision to be made about causality.

(3) Some cases may be the subject of several opinions from SERVIER in the event of an aggravation

(4) The law provides that in the absence of an offer from SERVIER or if the patient considers this insufficient, he/she may ask the substitution of SERVIER by ONIAM for compensation. ONIAM may accept or refuse this substitution (in particular if SERVIER's offer is deemed to be in conformity with the compensation notice issued).

(5) SERVIER's offers are based on the opinions of the ONIAM college and apply the compensation grids applied by ONIAM.

(6) Discussions between the patient's lawyer and SERVIER's lawyers.
